

DIRECTIVES OF THE OPERATOR OF PŘÍBRAM AIRPORT (LKPM) č. 2/2016

Landing charges at Příbram Airport (LKPM)

I. INTRODUCTORY PROVISIONS

1. Purpose

1.1 The purpose of the directive is to clearly define the amount of landing fees and the method of their collection at Příbram LKPM Airport.

2. **Binding**

- 2.1. This directive is binding for all users (natural and legal persons) at Příbram LKPM airport.
- 2.2. At the request of the aerodrome operator, the user, operator or owner of the aircraft shall produce the aircraft logbook for inspection of the landing charges.
- 2.3. Pilots are required to use only published runways. For arrival to and departure from Příbram Airport (LKPM), two-way radio communication must be provided. Pilots are obliged to report their position and intended activity even outside the operating hours of the RADIO station.

- 2.4. Landings outside the runway will be subject to an Air Traffic Incident Report in accordance with Regulation L-13.

II. AMOUNT OF LANDING FEES

- The basis for calculating landing fees is the MTOW of the aircraft as stated in the airworthiness certificate.
- 2. The landing fee is a fee for one (1) landing or one (1) touch and go at Příbram Airport (LKPM). It applies to both paved and grass runways.

3. The fee is CZK and EUR including VAT.

III. CHOICE OF FEES

1. The user (aircraft operator) is obliged to pay landing fees for the landings made. If the aircraft does not have an operator, the owner of the aircraft shall be responsible for payment of landing fees.

2. Payment of landing fees:

- a) Operators/owners of aircraft registered in the LKPM system pay the fees once (once per month) on the basis of an invoice issued by the operator of Příbram Airport. Invoices are issued by the 15th day of the following month for which fees are due. The invoice is due for payment within 14 days.
- b) in published time 1 APR 31 OCT, MON-FRI 0600-1600 SAT, SUN, HOL 0800-1600 Otherwise O/R 1 NOV 31 MAR MON-FRI 0800-1400 Otherwise O/R landing fees are paid at the RADIO station.
- c) Outside the published time, communication is recorded and aircraft movements are recorded by the camera system. Any landings made will be invoiced by the airport operator after the end of the calendar month, the invoice will be issued to the aircraft operator according to the aircraft registration number (so-called "matriculation"), if the aircraft does not have an operator, the invoice will be issued to its owner. The invoice must be paid by the user, operator or owner of the aircraft by the due date.

IV. FINAL PROVISIONS

1. Efficiency

- 1.1. This Directive is issued as an order of the operator of Příbram LKPM Airport within the meaning of Section 31(2) of Act No.49/1997 Coll. on Civil Aviation as amended.
- 1.2. This Directive No. 2/2016 2nd edition of December 2022 shall enter into force on 1 January 2023.
